This study will require 2 visits.

1st visit = 4 hrs (in person on August 15, 2011)

2nd visit = 10 mins (via e-mail)

You will be compensated two ways for your participation in this study.

The first way is in the form of CEUs or COAs.

A Certificate for 3.0 Continuing Education Units; 3.0 Continuing Education Credit Hours of Category 1; or 3.0 Continuing Education Units of Category A will be awarded upon completion of this training and of a completed evaluation.

The second way is in the form of a \$20 gift card.

Mailed to participant upon completion of a follow-up survey (via e-mail) 2 weeks after the study.

If you decide to participate, you will be randomly assigned to one of two conditions.

You will either be asked to attend the training on social attitudes and mental illness presented by Jennifer Brown & Thomas E. Arthur.

Or, you will be assigned to a waitlist control group in which you will be asked to attend the training “Sleep and You (Tube)” presented by Carole Frank.

(Both randomly assigned conditions will be eligible to receive 3 CEU/COA credits and the \$20 gift card).

This study is *free* to attend.

Registration is limited to 60 participants.

There is a screening process for this study.

You must be a provider or administrator of mental health services and have not had any training on social attitudes and mental illness to participate in this study.
